Re: Greystone Homicide Investigation.

Commander,

In reference to the above-captioned matter you are directed by this office to select your most experienced and most senior state trooper to investigate the serial killings in Greystone Psychiatric Park in Morris Plains. At the behest of Greystone's superintendent, Doctor Cliff Arbit and the Chief of Police of Morris Plains, the Greystone murders are now a state matter.

The detective you choose must be backed up by another experienced state trooper due to the extremely dangerous climate in Greystone. Your detective will be inserted at Greystone under deep cover. His true identity will be kept a secret from everyone except the trooper assigned to support your investigator. We promised Dr. Arbit all of our assistance but we did not specify what form that help would take. Since anyone on the grounds of Greystone is a potential suspect we must operate on that premise with the very best operational security. Therefore, **no one will be informed of this covert operation beyond me, you, your detective and his partner.**

All of the information contained within this file should be given to your detective so that he or she is fully apprised of the Greystone situation. To summarize the contents of the file here are a recap of the facts known to us:

There have been four deaths at Greystone Park in the past 45 days, which is unprecedented. One of them is an apparent suicide and should not be within the scope of your criminal investigation. One of the deaths, seemingly an accidental shooting by a deer hunter with a .22 caliber rifle, should be looked at more carefully since the shooter was never apprehended. The other two deaths are blatant homicides.

Jane Doe #1 jumped off the roof of the main Greystone building. Due to patient confidentiality concerns, all patient references are made generically. Her patient records are sealed, even to us, but Dr. Arbit has disclosed in strict confidence that Jane Doe #1 suffered from severe depression, had attempted suicide in the past and her jump is not unexpected given her history. She had recently been switched to new medication and the pharmacological profile of that medication combined with pathology tests indicate she was very under-medicated for a patient in her condition. Jane Doe #1's death is not considered a murder but is included in this report so that your detective is up-to-date on

current events prior to their undercover duty on the grounds of Greystone. The population of Greystone was already jittery because of this violent suicide. The possibility of a serial killer on the loose has patients and staff alike in an uproar, exacerbating the situation further.

The murder of Jane Doe #2 was committed in the greenhouse. The murder weapon has not been recovered. All relevant suspects and witnesses have been thoroughly questioned. The gardener should be considered a suspect due to a weak alibi. No other signs point to his involvement but his lack of a verifiable alibi demand he be considered.

Dr. Chung's death, drowning in a shallow pond, was certainly an intentional criminal act. A small animal couldn't have drowned in that pond let alone a fully grown man. Dr. Chung had no known enemies; he was fondly thought of and well respected among patients and colleagues. MPPD and GPD see no connection between the gardener and Dr. Chung and therefore no motive. QED it is possible the gardener killed Jane Doe #2 and highly improbable he murdered Dr. Kwon Chung.

It is possible we have two distinct murders to solve and two entirely innocent deaths. All avenues must be explored and no assumptions regarding any of these events should be made. The governor himself is deeply concerned by the recent events in Greystone and wishes a very quick conclusion to this state investigation.
